Countless Christians down the ages (including doctors, lawyers, scientists and historians) have not only been convinced by the evidence, but testify to knowing Jesus and his lifetransforming presence.

It was all made up...

Why invent a story with women as key evewitnesses, when their testimony was not legally acceptable? Why describe Jesus as physical and yet also sometimes unrecognised. and able to enter a locked room etc.? It was hardly invented to convince sceptics!

People just don't rise...

This is hardly a new insight! First Century people were just as able to 'sniff out a hoax' - everyone knew people didn't rise... yet thousands were persuaded that Jesus had. The event changed people's whole way of thinking (and still does!)

What about hallucinations?

The accounts of Jesus sightings just don't fit the normal patterns nor do they explain away the empty tomb

Answering Objections

The reality of crucifixion (and burial practice) makes this absurd. The soldiers knew their job their own lives depended on getting it right! Could a 'half-dead' Jesus launch Christianity?



There was some mistake...

Then why wasn't it dealt with? If the wrong tomb was visited, or if authorities took the body, then why wasn't it produced? Plenty of Jewish and Roman officials would have loved to stop the whole movement!



All suggested explanations' are unconvincing!

Only the actual, physical resurrection of Jesus fits the facts.

In fact most people don't interact with the evidence - they just ignore it.

You have to choose one out of a dozen surgeons / to save your life... CLUE: eleven

of them are dead!)
